**Authorization for Payment of Fees - Electronic Bank Draft or Credit/Debit Card**

I authorize Heritage Hills Golf Course and the financial institution or credit card company named above to deduct the amount of my monthly fee from the account identified above. I understand my automatic payment will be deducted on the 16<sup>th</sup> day of each month. Changes in bank account or credit card information must be submitted by completing a new Membership application form and filling out the payment information section. Changes must be received by the last day of the month in order to be processed for next month's payment. Cancelling a bank draft or credit card does not cancel a membership. In the event that a bank draft is revoked or an account is closed and new bank or credit card information is not received, the membership will be transferred to the "annual payment" option and the remaining amount due under the terms of the Contract will be owed. Account balances due to the Club shall be payable no later than 30 days following the statement date. If any payment is not received within 90 days of the due date, the applicant hereby authorizes the Club to charge the amount due, plus any applicable fees or penalties, to the credit card listed on the account. Early termination will only be accepted in the event of a member who passes away or a member who has accepted a military assignment out of the area. **A \$30.00 return fee will be charged for each returned bank draft or declined credit card (i.e. Revocations, Closed Accounts, & Non-Sufficient Funds).**

**I agree to abide by the following:**

I agree to abide by all rules, regulations and bylaws of Heritage Hills Golf Course. I understand and agree that this membership will begin on the date that this Contract is signed and will run continuously, renewing on an annual basis, until a cancellation form is filled out and submitted by the Member or notice of cancellation is mailed by Heritage Hills. I understand that this membership will automatically renew for all subsequent years unless cancelled pursuant to this agreement. I also understand that management reserves the right to increase the fees for subsequent membership terms by notifying me in writing 30 days prior to the start of the new membership term at my last known address or email. I understand that in the event of a default of this Membership Agreement by the Member, Heritage Hills Golf Course shall have the option to revoke my membership and all rights and privileges of Heritage Hills Golf Course with no refund of any amount previously paid.

**Waiver/Release**

I hereby agree to participate and/or engage in the use of the course, equipment, facilities and programs offered by the Club upon the understanding and agreement that:

1. I am aware of the risks of illness or injury inherent in any golf or exercise activity. These injury risks include, but are not limited to: being hit by golf balls, golf clubs, golf carts, or lightning; stepping or tripping in holes or other natural indentations in the ground; injury from insects, animals, birds or snakes, drowning; pulled muscles or other sprains, strains or injuries. I am participating in the Club’s programs upon the express understanding that I hereby indemnify, defend, waive and release the Club, its employees, agents, officers, Directors, Successors, and Assigns from any and all claims, costs, liabilities, expenses or judgments, including attorney’s fees and court costs (hereafter referred to as the “Claims”) arising out of my participation and the participation of my family and guests in the program(s) or any illness or injury resulting there from, and hereby agree to indemnify and hold harmless the Club from and against any and all such Claims defend, indemnify and hold harmless.

2. Heritage Hills Golf Golf course and facilities will be maintained to allow for normal golf activities. There is no guarantee as to the condition of the course or any amenity included in this membership. Members will have access to amenities listed in this agreement subject to availability, which is to be determined at the sole discretion of Heritage Hills Golf Course. Certain private and public events may dictate that the golf course, practice areas, restaurant and/or other areas of Heritage Hills Golf Course be closed. Member understands and agrees that nothing in this Membership Agreement shall entitle member to any of the facilities on any particular day nor to any discount or refund on account of any limited access. Member further understands that access to the course, practice facility and the restaurant and other privileges and benefits may be limited by Heritage Hills as necessary. No member is entitled to a refund or return of amounts due to damage to or condition of the golf course or any amenity. Further, Heritage Hills Golf Course shall have no liability for temporary suspension of any privilege due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions or any and all other matters beyond control of Heritage Hills Golf Course.

**Events & Outings**

The Annual Membership can be used to play in Men's or Ladies Club events when they are on those clubs' designated days. An annual Member who plays in an outside golf event or tournament will be subject to the applicable green fee associated with said event. At times, there will be club-organized events in which The Club will allow Member to use their pass in lieu of a designated green fee. Outside events are not limited and at the sole discretion of Club management. Outside events may require course closure.

**Private Golf Cars and Trail Fee**

All privately owned golf cars will need to be approved for use on Heritage Hills Golf Course by management, and will need to provide a certificate of insurance. All privately owned golf carts must display the appropriate decals. Only approved golf cars will be allowed on the golf course during an appointed round. No Golf cars will be allowed to use the cart path before dusk or before dawn.
